LA CE Update

Continuing Education Hours

Up to 50% of the required CE hours may be obtained through self-study.

Life; Accident and Health; or Life, Accident, and Health: 16 hours biennially

Property; Casualty; or Property and Casualty: 24 hours biennially

Bail Bonds: 12 hours biennially in courses specific to bail bonds

Personal Lines-Property and Casualty: 24 hours biennially

All Lines-L/H and P/C: 32 hours biennially

Producers licensed for property, casualty and/or personal lines complete a one-time 3 hour course on flood insurance. Current licensees must complete the training requirement no later than 04/30/2007.

Producers who are issued new licenses for property, casualty and /or personal lines authorities between 05/01/2005 and 04/30/2007 must complete the flood insurance education requirement as part of their first 2 year license renewal.

Course subjects must be for lines of insurance in which license is held.

Course Subject Requirements

Up to 50% of the required CE hours may be obtained through self-study.

L/H and P/C combined licensees must complete 12 hours in L/H and 20 hours in P/C.

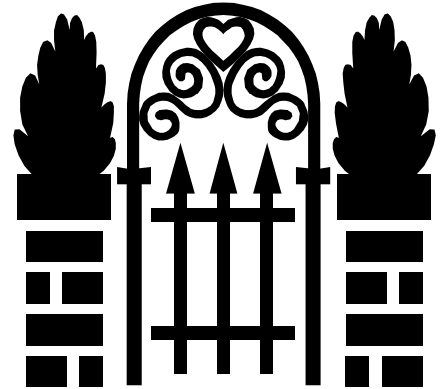
